Catholic Church Tours Inc., NFP will herein referred to as CCT. All deposits and sales are non-refundable. Cancellations and no-shows are fully charged. CCT is not responsible for any losses or damages to personal property, for injuries, expenses or damages incurred or claimed by tour participants not caused by CCT. CCT reserves the right to accept, remove, or decline any person participating or intending to participate in a tour. CCT reserves the right to decline admission to any person whose actions or conduct threaten the peaceful, undisturbed experience which participants seek from their experience. CCT and its agents and suppliers shall be under no liability to any such person for refund, or any compensation.

Neither CCT, nor its agents, volunteers or employees, is responsible for any items left at destinations, on the vehicle, or en route, for delays due to weather, road or traffic conditions, or accidents, group tardiness and/or acts of nature not caused by CCT. I understand and accept that tour destinations, schedules, and other itinerary items are subject to change without notice. Delays and substitutions are not subject to refund or discount. By purchasing a ticket(s) and/or participating in a tour, I assume the entire responsibility and liability of any claim, demand, action or suit based on or arising out of the injuries or damages to persons or property sustained or alleged to have been sustained in connection with or incidental to participation in the CCT tour, pilgrimage or event as a result from an act or omission of CCT, and further, I agree to hold harmless and unconditionally indemnify CCT, its agents, volunteers and employees, with respect to any injuries or damages to persons or property, sustained or alleged to have been sustained in connection with or incidental participation in the pilgrimage, tour, retreat or event hosted by CCT, or as a result of the alleged negligence of CCT, its agents or employees. In no event shall the liability of CCT exceed the amount paid by the Purchaser/participant of institution / parish / group to CCT for the services provided in connection with this agreement.

Any damage done at destinations will be charged accordingly at the discretion of the institution or business owner. I also waive any right to inspect or approve the finished photograph, video, or audio recording. I understand that this consent is perpetual, that I may not revoke it.
